I. CALL TO ORDER

The meeting was called to order at 7:00 p.m.

II. PLEDGE OF ALLEGIANCE

All present recited the Pledge of Allegiance.

III. DETERMINATION OF QUORUM

A quorum was determined for this meeting.

IV. APPROVAL OF MINUTES

MOTION by Mr. Gavin to approve the minutes from the January 29, 2018 meeting.

SECONDED by Mr. Michalowski and opened for discussion.

Corrections were noted:

- 1) Under Section A1. Energy Efficiency Projects-Town-wide ESPC Projects it should be noted the legacy systems that no longer cover the software affect the scheduled calendar settings AND impact energy savings.
- 2) Under section D1. Solar on Town Landfill, the second sentence should say "finalize" not "finalized."
- 3) Under section D3. Solarize Cheshire, the last sentence should state the first Solarize Cheshire program directly "resulted in" not "resulting in."
- 4) Under section D3. Solarize Cheshire, the word "the" should be removed from the motion made by Mr. Gavin.

The motion was returned to a vote and passed unanimously by all those present and voting.

VI. OLD BUSINESS

A. Energy Efficiency Projects

Town-wide ESPC (Energy Saving Performance Contract) project

In Mr. Clavet's absence, Mr. Gancarz stated the issues with the legacy systems at CHS have made progress, but are not resolved.

- 2) Community Pool Energy Efficiency Mr. Gavin stated he and Mr. Gancarz met with David Newman of ECG to begin drafting the RFP. Mr. Gancarz stated the RFP is expected to go out next week and the bids will be due in approximately 4-6 weeks.
- 3) Dryer Duct Cleaning Program
 Chairman Ogurick stated he has tried to contact Mr. Brucato about
 the status of his continued participation in this project, but has
 received no response to date. Ms. Doheny offered to contact Fire
 Marshal John Andrews regarding the CFD's interest in partnering
 with the Energy Commission on this program.
- 4) LED stadium lighting at CHS There was no report on this matter.

B. Benchmarking

1) Energy Star Portfolio Manager There was no report on this matter.

C. Publicity / Education / Outreach

News articles and letters to the Editor
 Mr. Michalowski stated there were no news articles or letters to the
 editor for this month.

Mr. Michalowski stated he has been in touch with Lou Nero regarding a new Republican member for the Energy Commission. Mr. Michalowski stated he is still trying to obtain utilization data for the EVCS at Big Y.

2) Energy Achiever Awards presentation

Mr. Gancarz stated he spoke with Jerry Sitko and Napoli and Whole Foods were recommended as recipients of the Energy Achiever Award. Mr. White recommended Paws Pet Resort. Bozzuto's was also mentioned as a potential candidate. Mr. Gancarz stated he will check with the Building Department and this matter will be revisited next month.

3) Energize Cheshire
Mr. White stated this matter can be removed from the agenda.

D. Clean Energy

1) Solar on town-owned landfill

Mr. Gancarz stated the solar panels are installed and connected. A witness test will be conducted on March 7, 2018. Mr. Gancarz stated the panels are expected to go "live" on or about March 15, 2018. Mr. Gancarz stated there will be a Smart TV in the lobby of Town Hall which will deliver real time information from the solar field. This data will also be available online.

Mr. White stated the 6th year of the small ZREC will open soon. Mr. White stated the Police Department is interested in a carport and there may be a good solar opportunity at the Elmwood pump station. Chairman Ogurick stated there is a small ZREC webinar on March 1st from 9-11 a.m.

2) Solarize Cheshire

Mr. White stated he and Mr. Gavin had a meeting with Smart Power to discuss the possibility of "solarizing" Cheshire. The program matches pre-qualified installers with individual towns. There was a brief discussion.

E. PBC Projects

In Mr. Clavet's absence, Mr. Gancarz stated a few current projects of the PBC are the lavatories at Norton, the cafeteria at Doolittle, ADA compliance in some lavatories and a new roof at the firehouse.

F. Grants, Rebates & Utility Programs

1) Early Involvement of Eversource There was no discussion on this matter.

G. CL&P Energy Reliability Program - Tree Trimming

Mr. Gancarz stated the tree-trimming is on-going.
